That the adventure trip expedition planned to Antarctica in the Summer of 07/08 and any preparatory training activities in Australia prior to departure are entered into by me voluntarily and at my own request and that I waive any and all claims I may now or in future have against, and release from all liability and agree not to sue Nik Halik, Peter Bland, Unique Frontiers PL, Financial Freedom Institute PL (the "Owners"), their officers, employees, guides, agents or representatives (including the owners and operators of Oceanwide Expeditions) (collectively referred to herein as the "Staff") in respect of any personal injury, death, property damage, or loss sustained by me as a result of my participation in this adventure trip expedition on either of the vessels Aleksey Maryshev or Professor Multanovski, due to any cause whatsoever, including without any limitation, negligence on the part of the Owner or its Staff.

I am aware that this adventure trip expedition, in addition to the usual dangers and risks inherent in an open ocean voyage, has certain additional dangers and risks, some of which may include physical exertion for which I may not be prepared, weather extremes being subject to sudden and unexpected change or violence, remoteness from normal medical services, and evacuation difficulties if I am injured, taken ill or otherwise disabled in any way. I accept all the risks inherent in this proposed adventure trip expedition including all usual and additional risks and whether or not such risks are expressly stated above, and the possibility of personal injury, death, property damage or loss resulting there from.
